

What is the Display Ad Network?

The Display Ad Network is a cooperative ad network of the state's weekly and daily newspapers.

Choose from either a 2x2, 2x4 or 3x5 Display Ad to advertise statewide. Your ad will appear one time during a designated week in newspapers statewide or by region.

Reach nearly 450,000 newspaper readers with this incredibly affordable and effective statewide advertising program. The South Dakota Display Ad Network offers a 75 percent savings over buying the same size ad in every newspaper in the state.

Why advertise in South Dakota newspapers?

South Dakota newspapers are the #1 source for local advertising information, out-pacing all other media including TV and radio, according to a 2021 statewide survey of 446 South Dakota households conducted by Coda Ventures for SDNA.

A 2x4 Display Ad is 3.2 inches wide by 4 inches deep.

A 3x5 Display Ad is 4.9 inches wide x 5 inches deep.
